

Ava Country Club Clubhouse Rental Agreement

Ava Country Club ("ACC") agrees to lease the Clubhouse located at 200 Country Club Drive, 501Y Hwy Y, Ava, MO 65608 to _____ ("Renter") according to the following terms and conditions:

1. Term: The term of the rental is **6 hours**, beginning on
2. Date: _____ at _____ a.m./p.m. (circle one). However, all functions must end by 12:00 am on weeknights, and by 2 am on Friday and Saturday nights, regardless of whether the 6 hour rental term has expired.
2. Rental Fee: The rental fee must be paid in advance by the Renter. The fee is \$100.00 for 6 hours.
3. Deposit: Two checks will be submitted for the clubhouse rental made payable to Ava Country Club. The appropriate rental fee of \$100.00, as well as \$50.00 security deposit check, to be returned to the Renter if the Clubhouse is left in clean condition and the key is returned within 12 hours.
4. Alcoholic beverages: Alcoholic beverages may not be served to anyone under the age of 21 years or intoxicated persons on the premises during the rental term. **Under Missouri Law, a host of any social event or business function where alcoholic beverages are served may be personally liable for any property damage, personal injuries, or loss of life resulting in whole or in part from the host's negligence in allowing any intoxicated guest or attendee to be served alcohol. Such liability may include harm to the intoxicated individual himself and also to total strangers involved in automobile accidents, etc. caused by that intoxicated individual.**
5. Smoking: No smoking or vaping is permitted within the ACC Clubhouse at anytime.
6. Assessments current: The Clubhouse is available for rental to any current member in good standing of the Ava Country Club. Non-members may use the facility only under the name of a current member in good standing.
7. Renter as host: The Clubhouse can only be rented under one name. The Renter must be at least 21 years of age. The host who has rented the Clubhouse in his/her name must be present at all times at the function for which the Clubhouse is rented and must be the primary host of the event. Under no circumstances can anyone rent/reserve the Clubhouse on behalf of a third party.
8. Pool: The pool area is separate from the Clubhouse and is not included in this rental. There should be no guest traffic on pool decks.
9. Music: Music, and /or any other noise, must be kept at a level that it cannot be heard in the surrounding homes in the area. The Renter of the Clubhouse will be responsible for seeing that there are no loud noises from the guests either coming to or leaving the function at the Clubhouse.
10. Damages: The Renter will be responsible for repair or replacement for any damage done to the Clubhouse and ACC property, including without limitation, the structure, landscaping, furniture, equipment, and window coverings. **Nothing may be attached to the windows, doors, walls or ceiling in any way (tacks, tape, staples, nails, etc.)**
11. Furniture: **Chairs and tables are NOT to be removed from this facility or taken outside.**
12. Clean-up of Clubhouse: The Renter will be responsible for cleaning the Clubhouse, the rest rooms and any other area used, including all equipment and furniture, immediately after the function ends. Cleaning includes sweeping the floors with the provided microfiber mops and damp mopping the floor as needed, and wiping down the counter tops, tables and chairs. The renter will also be responsible for placing all trash in the containers outside. No food items or containers will be left in the kitchen area or the refrigerator. If you bring it in, you must take it out following your event.
13. Heat/AC: Heat and/or AC must be returned to the original setting and lights are to be turned off by the Renter when function is over.
14. Lock doors: The Renter will lock the doors (front, back and entrances to both restrooms) when the function is over and at any time the Clubhouse is unoccupied.

15. Occupancy limit: The maximum occupancy for the Clubhouse is 150.

16. Assumption of Risk and Indemnification: The Renter will assume full responsibility for any and all accidents or claims that may arise as a result of any accident or for any other reason in connection with the function or lease of the Clubhouse by the Renter and said Renter hereby agrees to hold harmless and indemnify the ACC and its officers, directors, agents, and employees, of and from any and all claims, demands, losses, causes of action, damage, lawsuits, judgments, including attorneys' fees and costs (collectively "Claims"), including without limitation Claims for damage to property (including loss of use), bodily damage, or death, concerning, relating to or arising out of Renter's lease or use of the Clubhouse and premises.

17. No warranties: There are no warranties, expressed or implied, by ACC to Renter regarding the condition of the Clubhouse, rental premises, equipment or personal property contained at the premises, except as contained in this Agreement.

18. Miscellaneous: This Rental Agreement shall be governed by and construed under the laws of the State of Missouri. This Rental Agreement shall be binding on and inure to the benefit of the heirs, executors, administrators, successors, and assigns of the parties. The validity, interpretation and performance of this Rental Agreement shall be governed by the laws of the State of Missouri. The provisions of this Rental Agreement are severable. Should any provision of this be unenforceable, the remaining provisions shall remain valid and binding. No changes, modifications, amendments of any of the terms and conditions of this Rental Agreement shall be valid unless agreed to by the parties in writing and signed by their authorized representatives. This Rental Agreement embodies the entire agreement between the parties. All statements, negotiations, proposals or promises prior to the date of this Rental Agreement are merged herein and superseded hereby, there being no agreements, warranties, understandings or promises other than those written expressly herein.

19. Codes and Fines: All applicable jurisdictional laws, codes, and fire codes apply. Renter agrees to be responsible for any and all violations, fines and fees resulting from his or her rental, and shall indemnify and hold the ACC harmless for said violations, fines and fees.

20. Violation: Violations of these rules will be determined by the Board in their sole discretion. Violations to the clubhouse rules and policies are addressed on a case by case basis by the Board of Directors. The Board of Directors will decide if a violation has occurred from the person(s) claiming the violation, the Owner/Resident who rented the Clubhouse, and any other relevant people. For first offense, minimum consequences to the Renter may include forfeiture of the deposit and a 6 month waiting period before being able to rent again. For a second offense, forfeiture of the deposit and a two year waiting period.

21. Return of the Security Deposit: The \$50.00 security deposit will be retained by the ACC to offset its damages if the Clubhouse is not left in a clean and orderly condition. The Clubhouse Coordinator or Board Member has the authority to determine if clean up meets specifications and has final say. In addition, the Renter will be liable for any and all additional damages suffered by the ACC as a result of Renter's use of the premises.
